This project is still awaiting confirmation of our title to the building, via Land Registration, necessary for Vale funding.

#### **Subsidence**

Thanks to a most generous grant of £5,000 (two years' allocation: 2018/19 – 2019-20) from Oxfordshire County Council, via the County Councillors' Priority Fund, kindly supported by our County Councillor, the parish council has engaged Debbie Pritchard of Forge Engineering Design Solutions, Abingdon. Debbie visited the site in August, examined the building internally and externally, including two trial pits excavated to her specifications, and is preparing a report to include building, below-ground drainage and guttering specifications to arrest present and prevent future subsidence. She will include a list of recommended contractors to whom these specifications may be forwarded for costings and quotes.
